II. Name:

RUNE - Procurement of Materials for Broadband Network

III. Description:

RUNE aims to deploy a high-capacity fiber network targeting underserved areas in Slovenia and Croatia. The infrastructure will provide residents and small-businesses with a gigabit Next Generation Access (NGA) broadband infrastructure. RUNE will offer wholesale services only, on an active layer open access basis, to other service providers. The infrastructure deployment will leverage, to the maximum possible, the reuse of existing infrastructure and the most efficient technologies and cost reduction measures.

IV. Tender Scope:

RUNE invites potential suppliers to participate in the Request for Expression of Interest (RFI) for the procurement of materials required to deploy fiber network in the targeted areas in Slovenia and Croatia. The list of materials and estimated quantities to be procured are provided in Appendix 3. Note that the quantities are an estimate which might be subject to change. The technical requirements for the materials and cables are provided in Appendix 4 and 5.

V. Tender Procedure:

This tender is being conducted using a three-stage tender procedure. The first stage is a **Request for Expression of Interest (RFI)** to create awareness on the market, update tenderers' knowledge about the technology advancements, and the current state of the art for each procurement segment.

The second stage is the **Request for Quotation (RFQ)**, which is not binding, and done on the indicative targeted technical specifications, prepared on the basis of tenderers knowledge, experience, and information gathered in the RFI step. As a part of the documentation package bidders will have to submit a price list for selected materials and a draft contract will be received defining both parties' obligations.



Bidders that meet the requested criteria set in the RFQ stage will be shortlisted and only the highest-ranking ones will be invited to attend the third stage - **Request for Final Offer (RFFO)**. Meetings will follow, allowing Rune to discuss and evaluate potential options to optimize technical solutions and prices. Technical specifications might be updated in order to reflect potential options acceptable to Rune. Bidders will be asked to submit binding offers in the RFFO stage.

VI. RFI Submission Requirements:

Considering the list of materials to be procured as listed in Appendix 3 and the technical requirements for the materials and cables provided in Appendix 4 and 5 interested parties are requested to submit the following documents:
